



Tax Exemption By-Law T-082-26

Effective Date:
May 8, 2026

Part 1 Purpose

- 1.1 The purpose of this By-Law is to provide property taxes relief to nonprofit community, charitable, fraternal, educational, recreation, religious, cultural or sporting organization if, in the opinion of council, the organization provides a service that might otherwise be a responsibility of the council as allowed under Section 71(1) of the Municipal Government Act.

Part 2 Reduction

- 2.1 The property taxes due as regards to certain commercially taxable properties on Schedule "A" are reduced to residential tax rate;
- 2.2 The property taxes due as regards to certain taxable property or properties of certain organizations, including those in 2.1 above, are hereby reduced to the extent indicated in Schedule "A" attached. Only those properties fully exempt (100%) will be exempt from any applicable Area Rates as well, including the applicable Fire Rate.

Part 3 Eligibility

- 3.1 To be eligible to be placed on Schedule "A" the owner of the property must meet the requirements of Sec. 71(1) of the Municipal Government Act and Council must pass a motion authorizing the addition of that property, by amendment to this by-law.

Part 4 Ownership

- 4.1 When a property listed in Schedule "A" (attached) ceases to be owned by the organization named, then the exemption shall cease and the new owner shall immediately be liable for the full property tax, along with all the applicable Area Rates on the entire property for the remainder of the taxation year.

Part 5 Repeal

- 5.1 This By-Law hereby repeals and replaces Tax Reduction By-Law T-083-22 and Tax Exemption By-Law T-082-24.

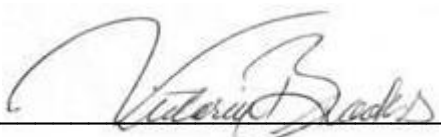
